SPECIAL SPEED LIMIT BYE-LAWS 2019

[Housing Estates]

Mayo County Council in exercise of the powers conferred on them by Section 46 of the Road Traffic Act, 1961 (No. 24 of 1961), as inserted by Section 33 of the Road Traffic Act, 1994 (No. 7 of 1994), Section 9 of the Road Traffic Act, 2004 (No. 44 of 2004), and in accordance with Circulars RSD 1/2014 of 15th October 2014 & RW 8/2015 of 21st April 2015, and having consulted with the Commissioner of An Garda Síochána, hereby makes the following Bye-Laws in respect of the area comprising the administrative area of the County of Mayo.

1. These Bye-Laws may be cited as the **Mayo County Council Special Speed Limit Bye-Laws 2019 [Housing Estates]**

2. These Bye-Laws shall commence on the: **15th December 2020**

3. In these Bye-Laws:

“the Act of 1961” means the Road Traffic Act, 1961 (No. 24 of 1961);

“the Act of 1993” means the Roads Act, 1993 (No. 14 of 1993);

“the Act of 1994” means the Road Traffic Act, 1994 (No. 7 of 1994);

“the Act of 2004” means the Road Traffic Act, 2004 (No. 44 of 2004);

“distance” means distance measured along the centre line of the road;

“national road” has the meaning assigned to it by the Act of 1993;

“road” means a public road.

4. These Speed Limits override previous default/current speed limits in the Housing Estates set out on the Schedules hereto.

Thirty kilometres per hour shall be the speed limit for mechanically propelled vehicles on the roads specified in these Bye-Laws.

Roads in Housing Estates in the Municipal District of Claremorris on which a speed limit of 30km/h is prescribed.

1	Ard Rua Estate	Claremorris	<i>Starting 420m west of the junction of L5538 (Ard Rua Estate) and the N60 and covering the estate within</i>

Roads in Housing Estates in the Municipal District of Castlebar on which a speed limit of 30km/h is prescribed.


No.	Name of Estate	Location	Description
1	Frenchbrook	Knockaskibbole, Castlebar	<i>Starting 12.5m North East of the junction of the L-17265 (Frenchbrook Housing estate) and L-1721 at Windy Gap/Pontoon Road and covering the estate within.</i>
2	Pound Grove	Pound Road, Castlebar	<i>Starting 9m North west of the junction of the L-57219 (Pound Grove Housing estate) and L-1728 at Pound Road and covering the estate within.</i>
3	Rocklands	Milebush, Castlebar	<i>Starting 9m South East of the junction of the L-57541 at Rocklands Housing estate and the L5754 and covering the estate within.</i>
4	Rocklands	Milebush, Castlebar	<i>Starting 24m South West of the junction of the L-57542 at Rocklands Housing estate and L-1704 at Belcarra Road and covering the estate within.</i>
5	The Oaks	Castlebar	<i>Starting 30m South East of the junction of the L-17293 (The Oaks Housing estate) and L-1719 at Turlough Road and covering the estate within.</i>
6	Sheridans Lane	Castlebar	<i>Starting 11m North West of the junction of the L-17197 (Sheridan's Lane Housing estate) and L-1719 at Turlough Road and covering the estate within.</i>
7	Lough Lannagh Village Road	Castlebar	<i>Starting 17m West of the junction of the L-17323 (Lough Lannagh Village Road) and R310 at Lannagh Road and covering the estate within.</i>
8	New Cemetery Road	Castlebar	<i>Starting 17m South of the junction of the L-57218 (New Cemetery Road Housing estate) and R311 at Newport Road and covering the estate within.</i>

9	Cemetery Road	Breaffy, Castlebar	<i>Starting 15m East of the junction of the L-57579 (Cemetery Road) and the L-5757 at Breaffy.</i>
10	Blackfort Manor	Castlebar	<i>Starting 17m South East of the junction of the L-57216 (Blackfort Manor Housing estate) and R-311 at Newport Road and covering the estate within.</i>
