SPECIAL SPEED LIMIT BYE-LAWS 2018

[Housing Estates]

Mayo County Council in exercise of the powers conferred on them by Section 46 of the Road Traffic Act, 1961 (No. 24 of 1961), as inserted by Section 33 of the Road Traffic Act, 1994 (No. 7 of 1994), Section 9 of the Road Traffic Act, 2004 (No. 44 of 2004), and in accordance with Circulars RSD 1/2014 of 15th October 2014 & RW 8/2015 of 21st April 2015, and having consulted with the Commissioner of An Garda Síochána, hereby makes the following Bye-Laws in respect of the area comprising the administrative area of the County of Mayo.

1. These Bye-Laws may be cited as the **Mayo County Council Special Speed Limit Bye-Laws 2018 [Housing Estates]**

2. These Bye-Laws shall commence on the: **01st April 2019**

3. In these Bye-Laws:
 - “the Act of 1961” means the Road Traffic Act, 1961 (No. 24 of 1961);
 - “the Act of 1993” means the Roads Act, 1993 (No. 14 of 1993);
 - “the Act of 1994” means the Road Traffic Act, 1994 (No. 7 of 1994);
 - “the Act of 2004” means the Road Traffic Act, 2004 (No. 44 of 2004);
 - “distance” means distance measured along the centre line of the road;
 - “national road” has the meaning assigned to it by the Act of 1993;
 - “road” means a public road.

4. These Speed Limits override previous default/current speed limits in the Housing Estates set out on the Schedules hereto.

Thirty kilometres per hour shall be the speed limit for mechanically propelled vehicles on the roads specified in these Bye-Laws.

Roads in Housing Estates in the Municipal District of Ballina on which a speed limit of 30km/h is prescribed.


